

## TERMS AND CONDITIONS

### PRELIMINARY

1. This Offer (defined in “Offer Details” section) is being run by **Vision Star** (“Seller”) on [www.flipkart.com](http://www.flipkart.com), Flipkart Mobile App, Flipkart Lite Platform (all three collectively, “Platform”), which Platform is owned and operated by Flipkart Internet Private Limited (“Flipkart”, “We” or “Our”).
2. By participating in this Offer, user (“You”, “Your” or “Customer”) agrees to be bound by:
  - a. these terms and conditions (“T&C”); and
  - b. the Terms of Use, Privacy Policy and other relevant documentation including any modifications, alterations or updates thereof, that are published on the Platform; and
  - c. Terms and conditions of the Seller.

### OFFER DETAILS

1. Offer is valid from 29th **November (00:00 hrs.) to 29th November (23:59 hrs.)** (“Offer Period”) on SBI Debit Cards.
2. The offer is available to all MasterCard, Visa and RuPay debit Card issued by the bank. All Magnetic stripe cards, Maestro Debit Cards, corporate or commercial Debit cards are excluded from this offer.
3. On purchase of Realme X2 pro (**All Variant**) sold by the **Vision Star** (Seller) on the Platform during the Offer Period, You will get Rs. 1250.00 instant discount using your valid and current Debit card.
